Carol “Lili” Lynton is the co-founder and operating partner of The Dinex Group, which operates 18 Daniel Boulud-branded restaurants. She is also CIO of HD American Trust, a family investment office formed in 1987, and an advisor to the Partnership Fund for New York City, a nonprofit organization that works to create jobs and help small businesses in New York City.

Prior to forming Dinex, Lynton co-founded Telebank, an internet banking pioneer sold to E*Trade in 1999. Lynton was an investment analyst at Sanford C. Bernstein and an M&A analyst at Lehman Brothers. She is a graduate of Harvard College and Harvard Business School.

Lynton serves on the boards of The Vera Institute of Justice, The National Bail Project, and GreaterNY. She is also a member of the Advisory Council of the Hamilton Project, a division of Brookings that develops proposals for a more equitable and robust U.S. economy.
